## REGULAR MEETING OF THE BOARD OF DIRECTORS OF THE MONTECITO FIRE PROTECTION DISTRICT

Held at Fire District Headquarters, 595 San Ysidro Road, August 15, 2011.

The meeting was called to order by Director Jensen at 8:45 am.

**Present**: Director Jensen, Director Newquist and Director Venable. Chief Wallace and District Counsel M. Manion were also present.

#### 1. Public comment:

Sue Leal Katnic thanked the Board for their assistance in the Upper Hyde Road rebuilding process and announced that her family moved into their home on Aug 6th.

T. Ederer advised that members of the Montecito Firemen's Association (MFA) hoped to get to know the Board members better in the future, and asked the Board to consider allowing the MFA to participate in the recruitment for a 5 member Board, and with the selection of the next Fire Chief.

### 2. Approval of Minutes of July 20, 2011 Adjourned Regular Meeting.

On a motion made by Director Venable, seconded by Director Newquist, the Board approved the minutes of July 20, 2011 adjourned regular meeting. Director Jensen abstained.

### 3. Approval of District warrants and claims.

After an explanation of payments made to Campbell Geo, and FAIRA, the Board unanimously approved the warrants and claims for the month of July on a motion made by Director Newquist, seconded by Director Venable.

#### 4. Approve Employee Reimbursement Disclosure report.

Chief Wallace explained that the Employee Reimbursement Disclosure Report includes all reimbursements that were made to employees throughout the year. The Employee Reimbursement Disclosure Report was unanimously approved on a motion made by Director Newquist, seconded by Director Venable.

#### 5. Station 3. Conceptual review of proposed design for Station 3.

Howard Leach, Matt Huntington and Susette Naylor of Leach-Mounce Architects reviewed conceptual sketches of their proposed design for Station 3. They clarified that their presentation reflects an overall appearance of the design, not floor plans. They also reviewed some of the guidelines outlined in the Montecito Community Plan.

Director Newquist asked that Station 3 updates be on future agendas. Ms. Naylor suggested that they hold a meeting for the immediate neighbors sometime before the land use committee meeting so that they can see the direction being taken with the Station 3 design; a larger community meeting can be held after the E.I.R. is complete.

On a motion made by Director Venable, seconded by Director Newquist, the Board unanimously accepted the conceptual drawings, and directed Leach Mounce Architects to move forward with their presentation for the September 6th land use meeting, and a report back at the September 19th Board meeting.

### 6. Consider letter in support of Santa Maria Air Tanker Base.

Chief McElwee advised that the County Chiefs voted to send a letter to Chief Tom Tidwell of the US Forest Service, with copies to all local legislators and the Board of Supervisors in support of the Santa Maria Air Tanker Base. Because the letter created positive momentum, Former Santa Barbara County Supervisor Willie Chamberlin requested that the Governing Boards of each individual agency also send letters of support.

On a motion made by Director Newquist, seconded by Director Jensen, the Board directed staff to author and send a letter to those whom they feel should receive the letter in support of an air tanker base in Santa Maria.

## 7. Review and consider response to Grand Jury Report entitled "Local Government Post Employment Benefits in Santa Barbara County – Complicated and Costly."

Mr. Manion reviewed the draft response to the Grand Jury and reported that it is due on September 19.

On a motion made by Director Venable, seconded by Director Jensen, the Board unanimously approved the draft response as submitted.
