## REGULAR MEETING OF THE BOARD OF DIRECTORS OF THE MONTECITO FIRE PROTECTION DISTRICT

Held at Fire District Headquarters, 595 San Ysidro Road, June 21, 2012.

The meeting was called to order by Director Jensen at 8:31 am.

**Present**: Director Jensen, Director Newquist and Director Venable. Chief Hickman and District Counsel M. Manion were also present.

## 1. Approval of Minutes of May 21, 2012 Regular Meeting.

The minutes of the May 21, 2012 Adjourned Regular meeting were unanimously approved on a motion made by Director Newquist, seconded by Director Venable.

## 2. Approval of District warrants and claims.

After an explanation of payments made for wildland packs, lighting upgrades, the vegetation management program, Fire Prevention District-wide mail out, and State Compensation insurance, the warrants and claims for May were unanimously approved on a motion made by Director Newquist, seconded by Director Jensen.

## 3. Adopt Resolution 2012- 05 regarding the 2012-2013 preliminary budget.

Mr. Cole asked how the public would access the preliminary budget. He was advised that District documents are available upon request.

Chief Hickman then provided information on District funding, items within the preliminary budget and projections for Station 3.

Chief Hickman reported on the following items: (1) there are currently two personnel members working on the Ozena Fire; (2) CalEDA Hazmat class was held at Station 1; (3) application to county planning for Station 3 is complete, story poles installation complete at Station 3 site; MBAR requested "agrarian" and "andalusian" features be considered for Station 3 design; upcoming County meetings for Station 3; (4) promotional process; and (5) status of the 5 member board;

The Board took no action.

### 10. Board of Directors report.

Director Venable advised that it was a pleasure working with the Montecito Firemen's Association negotiators.
